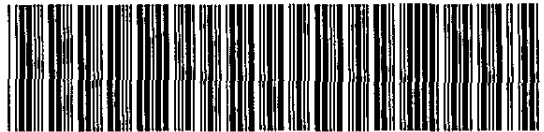

Dear Sir or Madam,

I believe I was successful in filing the UBR on line, but it has proven to be an excruciating exercise. I tried to do a fictitious name registration for a new general partner and that proved to be a "Catch 22" exercise in futility. It demands a Florida Document Number which there will never be since the situs of the trust, by Arizona Law, is Arizona.

The situation is "add/delete." The T.B. King Marital Deduction Trust is no longer any kind of partner having sold its' interest to other limited partners (who are child and child's trust of the deceased). Bertram A. King remains as Managing General Partner. Thomas F. King (a real person), 16262 Wayne Rd., Livonia, MI 48154 becomes a General Partner. The Eleanor A. Baker Trust (fictitious name), Bertram A. King, Trustee, 9058 E. Kenyon Dr., Tucson, AZ 85710-4446, becomes a general partner. The T.B. King MDT registration expires the end of the year and will not be renewed. It's situs is Arizona. None of the parties named are currently Florida residents. All of the general partners are 1% owners as general partners and 1/3rd owners of the remainder through the King Agricultural Trust (Arizona situs). The last time I did this, the fee was \$52.50 and it does not seem to have changed.

The Florida Agent, R.J. Hass is unchanged.


Hopefully, I got this right. If not, the e-mail above will get me. The change in the fictitious names deletes my Father's Estate (deceased) during the lifetime of my Mother (who died 27 May 04). My Father's Estate sold its two general partnership shares to my Brother (Thomas F. King, a natural person) and my sister's trust (Eleanor A. Baker Trust, a fictitious entity I believe). This change is on CR4A-001 with a fee of \$60 (to include a certificate of status) and the Certificate of Amendment with \$52.50 which I believe you already have. I have signature authority for every entity involved in this "exercise."

Also in hand I have what appears to be a UBR with a due date of 8 Sept 04 which leaves me mystified since I already filed a UBR on-line. In any event, block 12 is incorrect pending the changes and I'll have to wait for the document number on the EABT.

The three hour time change makes East Coast communications awkward and e-mail works best
