
SFA JADE GARDENS, LTD., a limited partnership organized and existing under the laws of the State of Florida, hereby files this Certificate of Cancellation and states:

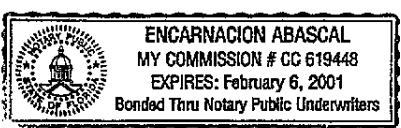


