AMENDMENT OF CERTIFICATE OF LIMITED PARTNERSHIP

Canterbury Place Partners, Ltd., a limited partnership existing under the laws of the State of Florida, pursuant to the provisions of Section 620.109 of the Florida Statutes, hereby amends its Certificate of Limited Partnership, filed on September 16, 1994, as amended on February 20, 1997, and now of record in the office of the Department of State, as follows:

Paragraph 5 of the Certificate, which now reads as follows: "The latest date upon which the limited partnership is to dissolve is: 31 December 2009", is amended to read as follows: The latest date upon which the limited partnership is to dissolve is December 31, 2020.
