The total amount of the capital contributions of the limited partners is \$158,363.20.

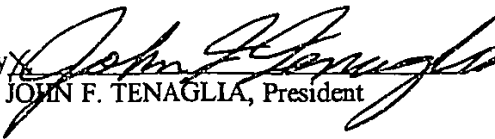
