Thank you for your letter of January 10, 1996, a copy of which is enclosed.

It is my understanding that the limited partnership was not registered due to failure to submit the filing fee for registered agent designation. Our check in the amount of \$35.00 is enclosed to cover that fee. For your information, prior to filing, I was advised by your office that all that was necessary was a fee equal to \$7.00 per \$1,000.00 capitalization, with a minimum of \$52.50 and a maximum of \$1,750.00.

It is also my understanding that the limited partnership was not registered because the name requested had been reserved by another individual. That other individual was Jordan A. 


