Dear Ms. Cushing:

I have received your letter and, as instructed, I have enclosed a copy of that letter. Since your letter did not contain our check in the amount of \$52.50 to us, I assume that you still have this check. Please let me know right away if I am mistaken.

Let me explain why we believe that the filing fee for this amendment is properly \$52.50, and not \$1750.00, as you have indicated. Barr-Bonner Family Limited Partnership (the "Partnership") was funded with an initial contribution of \$4,20,000 from the limited partners. This amount was contributed to the Partnership in its entirety on April 16, 1996, one day after the Partnership's original Certificate of Limited Partnership was filed. There have been no other contributions of property to the Partnership on the part of the limited partners in 1996.

When we filed the Certificate of Limited Partnership, we paid \$1750.00, which is the maximum amount payable under F.S. 620.182(3) for filing a certificate of limited partnership. As I understand that statute, if we had indicated the limited partners of the Partnership were going to add, say, \$10 million to the Partnership, \$1750.00 would still be the most that would be required to be paid. Thus, even if the amount of the contribution made by the partners were to have been shown as the proper amount in this case (i.e., \$4.2 million), the Partnership has already paid the maximum filing fee.

It is true that F.S. 620.182(4) speaks of the additional \$1750.00 filing fee that you mention in your letter when an affidavit is filed showing capital contributions in excess of those anticipated. However, that statute indicates that the filing fee is "... based on the additional amount of the contributions of the limited partners . . . " In this case, there have in fact been no additional amounts of capital contributions by the limited partners. As indicated above, the only capital contribution was the one made on April 16, 1996, and the Partnership has already paid the maximum allowable by law on account of that contribution.

In light of the foregoing, we respectfully request that the Department of State reconsider its position in this matter.
