SUPPLEMENTAL AFFIDAVIT OF CAPITAL CONTRIBUTIONS OF
OAKFIELD PROPERTIES LIMITED, A FLORIDA LIMITED PARTNERSHIP

The undersigned general partners of Oakfield Properties Limited ("the Partnership"), a Florida limited partnership, hereby certify as follows pursuant to Florida Statute §620.112:

As of the date set forth hereinbelow, certain limited partners of the Partnership have contributed to the Partnership real property with a fair market value of \$43,000 as an additional capital contribution.

As of the aforesaid date, said contributing limited partners have received additional units in the Partnership in exchange for said contribution.

Immediately prior to the aforesaid date, the Partnership had previously authorized 10,000 units of ownership interests in the Partnership, all of which were issued and outstanding. The Partnership hereby increases its authorized ownership interests to 25,000 units; as of the aforesaid date, with respect to the additional 15,000 units of ownership interests, 3,440 units, in the aggregate, have been issued to said contributing limited partners.
