
Enclosed please find an application for reinstatement of the above-mentioned limited partnership along with a \$2,640.00 payment covering five years of annual report fees and the \$8.75 certificate of status fee. The partnership filed it's last UBR in 1999.

Wooten Family Partnership has been under Chapter 11 bankruptcy for the past few years. During that time there was a turnover of the partnership's legal and accounting professionals and a change of its registered agent. The partners, inexperienced in these matters, were unaware that an annual filing was required and, since they were not the registered agent, received no notifications regarding the annual filing. It is believed those notices were mailed to previous agent who failed to forward them.

Based on the circumstances we respectfully request that you accept the enclosed payment and abate the reinstatement penalty.

Please note that, in order to avoid future mix-ups, one of the partners has agreed to serve as the registered agent.
