Please revise the title of this document by eliminating the words "AND AFFIDAVIT OF CAPITAL CONTRIBUTIONS."

Please note that there is no provision in the law to file an Amended and Restated Certificate AND AFFIDAVIT. You can only file an Amended and Restated Certificate.

ALSO, please refer to "SECTION 620.109" and not "SECTION 620.108." The "108" section deals with the formation of a limited partnership. It's "109" that deals with the Amended and Restated Certificate.
