

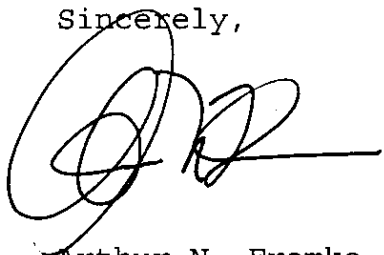
Gentlemen:
