3. Amendments. Paragraph 3 and 5 of the Certificate of Limited Partnership shall be deleted in their entirety, and the following shall be inserted in their stead:

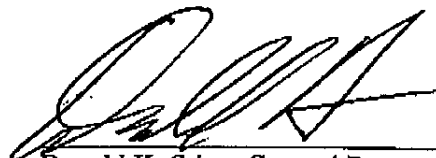

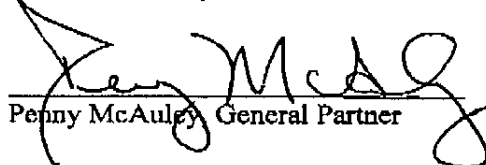
