#### CERTIFICATE OF AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP OF TALLAHASSEE POWER CENTER, LTD.

- (c) Borrow money and incur other debts and obligations from any person or institution or entity (including, but not limited to, any borrowings from, and debts and obligations to, the General Partner or any Affiliates of the General Partner), and issue evidences of indebtedness in connection therewith, on such terms as shall be acceptable to the General Partner, and secure any such indebtedness or obligations by mortgage on, security interest in, and/or other lien on, any property or asset of the Partnership;
- (d) Change the amount of, amend, modify or change the terms of, and extend the time for payment of, or retire, discharge or refinance, any indebtedness or obligation of the Partnership; and change the amount or value of, modify or change the nature or type of, or make any other modifications or changes with respect to, any security granted or collateral given for any Partnership indebtedness or obligation, and amend, modify or change the terms of any agreement, instrument or document with respect to any such security or collateral;
