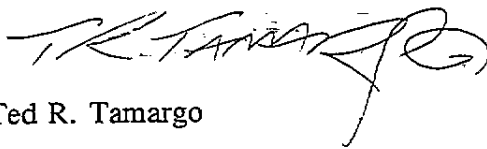

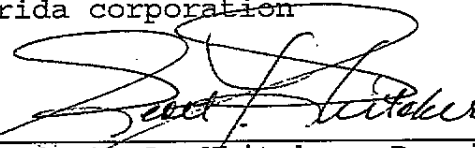
3. It is anticipated that there will be no additional capital contributions by the Limited Partners to the Partnership.

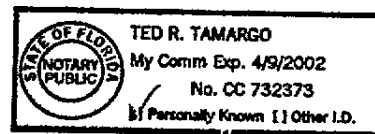
