2. The amount of additional capital contributions anticipated to be contributed by the Limited Partner is \$4,100,000.00.

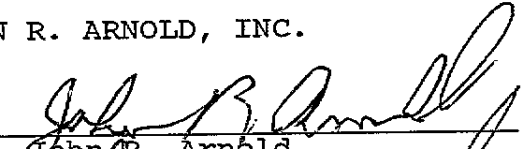

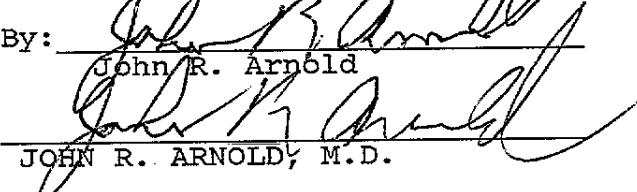
