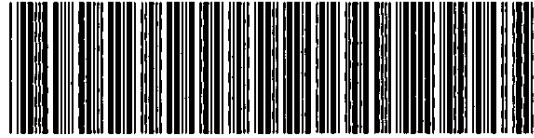

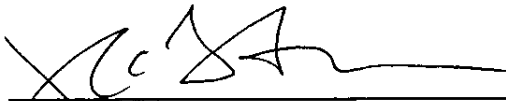
3. **Reason for Filing Certificate of Dissolution.** This Certificate of Dissolution is being filed due to the dissolution and the completion of winding up of the Partnership.

**RICHLAND MANAGEMENT, LTD.**

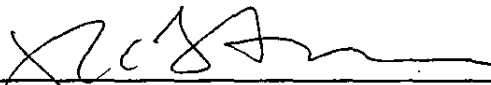
