- 1. The name of the Partnership is Uncommon, Ltd.
- The Certificate of Limited Partnership of the Partnership was originally filed with the Florida Secretary of State on April 13, 1999.
- 3. The Certificate of Limited Partnership is hereby amended by the inclusion of the following new Section 7:
  - "7.
