BEFORE ME, the undersigned authority, personally appeared **SALLY I. GILLESPIE, GENERAL PARTNER, of NEW SMYRNA BEACH, FLORIDA**, the sole general partner of **MONTREVILLE LIMITED** (the "Partnership"), who, upon being duly sworn, certified as follows:

1. The original **AFFIDAVIT OF CAPITAL CONTRIBUTIONS OF MONTREVILLE LIMITED, A Florida Limited Partnership**, heretofore filed the **23rd day of June, 1999**, set forth the amount of capital contributions, to the Partnership made by the limited partners was, in the aggregate, **Nine Thousand Nine Hundred and No/100 (\$9,900.00) Dollars**.

3. At this time, it is not anticipated that any further capital contributions will be made by the limited partners.

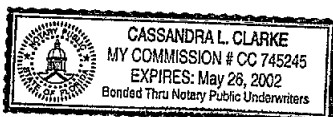
