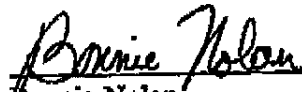

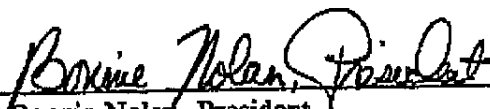
AFFIDAVIT OF CAPITAL CONTRIBUTIONS
