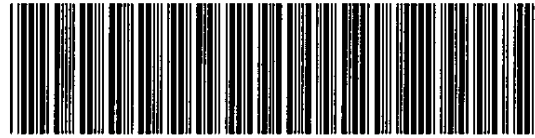


ARTICLES OF AMENDMENT
