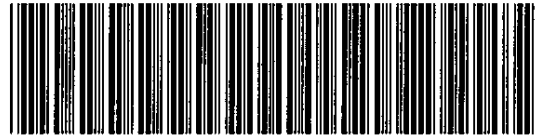




ARTICLES OF AMENDMENT
