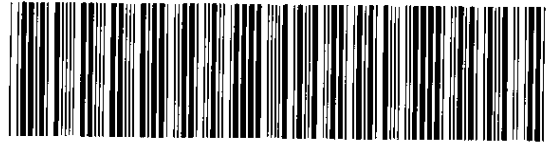

CHAPTER 4281—[No. 167.]

AN ACT to incorporate the Most Worshipful Grand Lodge of Free and Accepted Masons of Florida, and all Subordinate or Particular Lodges Masonically Chartered thereby.

Be it enacted by the Legislature of the State of Florida:

Incorporation.

SECTION 1. That the Grand Master, the Deputy Grand Master and the Grand Wardens of the Most Worshipful Grand Lodge of Free and Accepted Masons of the State of Florida, as such order now exists and as its said officers are now constituted, consisting of Masons exclusively of the white race, and their successors in office, be and they are hereby declared to be a body politic and corporate, by the name and style of "The Most Worshipful Grand Lodge of Free and Accepted Masons of Florida;" and as such shall be capable and liable in law to sue and be sued, to contract and be contracted with, to plead and be impleaded, and to acquire, own, hold, possess and convey property, either real, personal or mixed, either by purchase, gift or devise; and to issue and grant Masonic charters according to its own constitution, by-laws, rules and regulations, to such subordinate, particular or individual lodges of Free and Accepted Masons of the white race, at such places in the State of Florida as it may see fit; and with full power, according to its own constitution, rules, by-laws and regulations, at any time to recall, abrogate, revoke or annul, for misuser or non-user, any such Masonic charter that it may have issued or

granted to any such subordinate, particular or individual lodge, or which it may hereafter issue or grant to any such particular, individual or subordinate lodges. And it shall have perpetual succession.

SEC. 2. The said corporate officers of such Grand Lodge shall be elected annually at the annual meeting of the said Grand Lodge in such manner and at such time and place as its constitution, by-laws and rules shall provide.

Annual election.

SEC. 3. An Act entitled "An Act to Incorporate the Grand Lodge of Florida," approved March 14, 1843, be and the same is hereby repealed; but all corporate rights, privileges, franchises and powers granted by said Act are hereby expressly reserved and continued to and in the corporation hereby created, who is its successor. And all contracts, bonds or other obligations heretofore contracted or entered into by such Grand Lodge are hereby ratified and declared to be binding and of lawful force and effect.

Repeal and continuation.

SEC. 4. The Worshipful Master and Junior and Senior Wardens, and their successors in office, of any and all particular, individual or subordinate lodges of Free and Accepted Masons of the white race, that have heretofore or which may hereafter be organized and masonically chartered in the State of Florida by the Grand Lodge mentioned in Section 1 of this Act, according to the constitution, by-laws and rules of such Grand Lodge, are hereby declared to be separate and independent bodies politic and corporate, under such several corporate names and styles as may be assigned to them respectively in their Masonic charters granted to them by such Grand Lodge, with the right of corporate succession, so long as the Masonic charters granted to them by such Grand Lodge shall remain unrevoked by such Grand Lodge; and as such, by their several and respective corporate names, shall have the power to contract and be contracted with, to sue and be sued, plead and be impleaded; and to acquire, own, hold, possess and convey property of all kinds, real, personal and mixed, so long as their Masonic charters shall remain unrevoked by said Grand Lodge; and to elect their said corporate officers at such times and places as their own rules, regulations and by-laws, not in conflict with the rules and regulations properly laid down for them by such Grand Lodge, may provide.

Separate bodies.

Powers.

SEC. 5. All properties, real or personal, now held in trust for such Grand Lodge, mentioned in Section 1 of this Act, may be conveyed by the trustees thereof by deed directly to such

Conveyance of properties.

Grand Lodge in its said corporate name, subject to any and all obligations to which it may be subject in the hands of said trustees.

Deed by trustees.

Sec. 6. All properties, real or personal, now held in trust for any of said particular, individual or subordinate lodges mentioned in Section 4 of this Act, may be conveyed by deed by the trustees thereof directly to such lodges in their corporate name, subject, however, to all obligations to which it may be subject in the hands of such trustees.

Revocation of charter.

Sec. 7. Whenever the Masonic charter of any particular, individual or subordinate lodge, mentioned in Section 4 of this Act, shall be recalled, revoked, abrogated or annulled by the Grand Lodge mentioned in Section 1 of this Act, such particular or individual lodge shall cease to have corporate existence, except for the purpose of being sued for its legal obligations; and upon such cessation of its corporate existence all of its properties, real, personal and mixed, shall revert to and belong to the said Grand Lodge, subject to any debts that may have been contracted by such particular or individual lodge. But such Grand Lodge shall in no event be responsible or liable for any indebtedness created by any particular, individual or subordinate lodge.

Liability for indebtedness.

Former charters annulled.

Sec. 8. All charters of incorporation, whether by the general incorporation laws of this State, or by special Acts of the Legislature, heretofore granted or issued to any of such particular or individual or subordinate lodges mentioned in Section 4 of this Act, are hereby revoked, abrogated, annulled and repealed, and the provisions of this Act shall stand in lieu thereof.

Repeal.

Sec. 9. All laws or parts of laws in conflict with the provisions of this Act are hereby repealed. And this Act shall take effect immediately upon its approval by the Governor.
