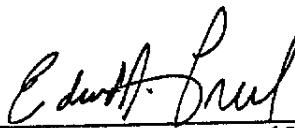

DOES HEREBY CERTIFY:

FIRST: That the Board of Directors duly adopted resolutions proposing to amend the Certificate of Incorporation of this Corporation, declaring said amendments to be advisable and in the best interests of this Corporation and its stockholder, and authorizing the appropriate officers of this Corporation to solicit the consent of its stockholder therefor, which resolutions setting forth the proposed amendments are as follows:

RESOLVED, the Certificate of Incorporation of the Corporation be amended by replacing Article I thereof so that such Article shall be and read as follows:

"Article 1. NAME

The name of this corporation is Data on Air, Inc. (the "**Corporation**")."

SECOND: That thereafter said amendments were duly adopted in accordance with the provisions of Section 242 of the General Corporation Law by written consent of the sole shareholder of the Corporation in lieu of meeting in favor of said amendment in the manner set forth in Section 228(a) of the General Corporation Law.
