STATE OF DELAWARE CERTIFICATE OF AMENDMENT OF CERTIFICATE OF INCORPORATION OF MULTITHEMATIQUES, INC.

Multithematiques, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), hereby certifies:

<u>FIRST</u>: That the Board of Directors has advised and proposed to amend article FIRST of the Certificate of Incorporation of the Corporation to read in its entirety as follows:
