We are writing to respectfully request the abatement of the \$9,000 civil penalty for the above-named company. As discussed during our phone conversation, you indicated that a written statement was required to resolve this matter. As you may recall, the company is in the process of complying with state statutes and registering in all states where they are not qualified. PEAK is a temporary technical staffing services company that does occasionally place people in Florida. Therefore, we are registering to do business in your state. Although the application indicates that PEAK has been transacting business in Florida since 1992, we believe that this may not be accurate. PEAK was involved in merger in 1992 with a company that did transact business in Florida that year. However, since the merger in 1992, the activity of PEAK in Florida has been minimal. We are asking to register in Florida upon qualification and acceptance of the application.
