

The Articles of incorporation may supersede the two-thirds vote requirement by specifying any smaller or larger vote requirement not less than a majority of the outstanding votes of such members entitled to vote, and not less than a majority within each class when class voting applies.  When member approval is by written consent, all members must be given notice of the proposed amendment at least five days before the consent is signed.
