Dear Ms. Harvey:

I am writing to request abatement of the \$1,150 fees and penalties charged to Abraham Technical Services, Inc. due to our failure to obtain a certificate of authority prior to transacting business in the State of Florida.

In February 1999, we applied for and received a permit to collect and remit sales tax from the Department of Revenue. We hired our first Florida employee in March 1999. We failed to register with the Secretary of State at that time. Upon filing our 1999 income tax return, our CPA indicated that we need a Florida Tax ID number. At this point we realized that we did not have one. In May 2000, I submitted the Application by Foreign Corporation for Authorization to Transact Business in Florida.

I started with Abraham Technical Services in August 1999. My predecessor had very little experience with new state registrations and missed this important step. Also, during the first and second quarters of 1999, the Accounting Manager was dealing with significant business software problems that required significant overtime hours. It appears that these problems and extra hours probably contributed to the oversite. Abraham Technical strives to comply with all laws and regulations in the states that we operate.

Again, we request an abatement of the fees and penalties. Thank you in advance for your consideration.




