Dear Jerry:

Thank you very much for taking the time last week to discuss this matter via phone, and for your offer of settlement in the amount of \$8,100. I have conveyed that offer to our client, together with my opinion regarding the applicable law.

As you are no doubt aware, section 607.1501(2), Florida Statutes, has never been directly construed by either a Florida or federal court. Interestingly, subsection (2)(j) thereof **EXCLUDES** from the definition of "transaction business," "**Transacting business in interstate commerce.**" It seems to me that this exclusion is consistent with the federal constitutional prohibition of any state restrictions being imposed on interstate commerce.

While the amount in dispute may not justify the costs of a judicial challenge, absence application of section 1988 of the Civil Rights Act for payment of our client's fees and costs, the facts of this case as set forth in our client's recent affidavit present a tempting issue which is ripe for adjudication. However, our client is willing to forego the risk of non-reimbursement of these potential fees and costs if the state is willing to **settle all issues for the sum of \$5,000.** In addition, our client would, within 30 days, complete the necessary filing with your department to "authorize" it to continue it's existing business practices, including the maintenance of annual reports and fees.

This settlement is offered **without prejudice** to our client's right to contest all of these issues in the event litigation becomes necessary, and is not intended to be admissible in any such proceedings as an admission of liability, which is, in fact, contested. I am hopeful that you can favorably recommend this proposed settlement to the department, and for that purpose it shall remain open until **Friday, March 2, 2001.**

4. This affidavit is made for the purpose of inducing reliance hereon by the Florida Department of State and in support of the corporation's position that it is not required to obtain a certificate of authority from the state of Florida.

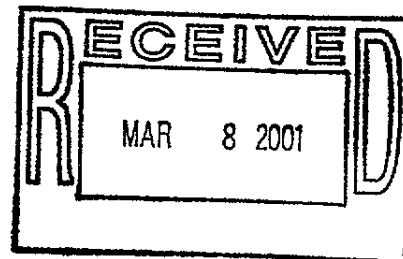

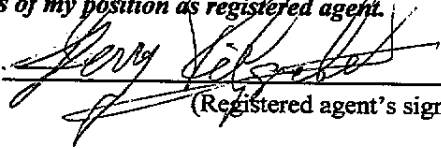

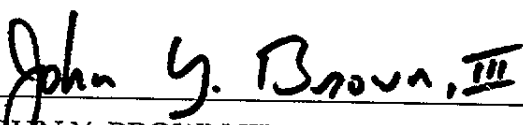
