It has just come to our attention that Genesis was revoked in 2003 for failure to file an annual report. Our Consumer Collection Agency Registration (Audit number CCA 0500456) is up to date, however. It appears that there was a 2003 filing which was rejected; but we have no knowledge of Yazel Pardo, the name that appears on the Corporations Online website as the Genesis submitter. In reviewing the forms I was referred to by telephone, I believe the correct fee is \$1,050 in order to reinstate from 2003 to the present. It is my understanding that this will replace the annual report for this year and that we will receive a postcard reminder subsequently.
