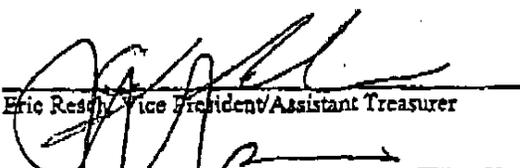
POWER OF ATTORNEY
