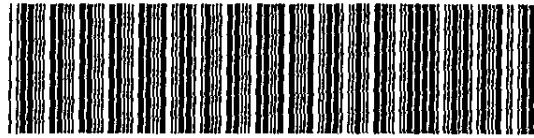

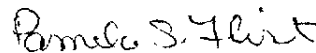

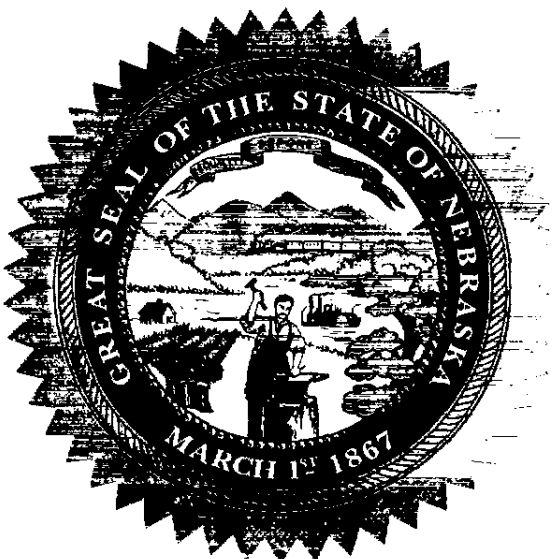

NAME

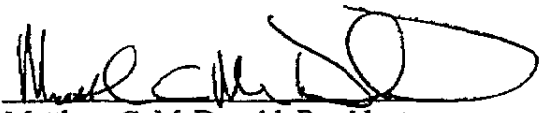
The name of the Corporation is Vectorworks Marine, Inc. (the "Corporation").
