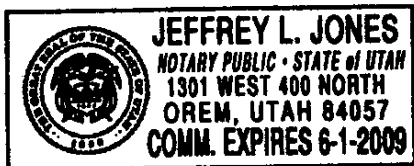
1. Kevin Stoker is the Vice President of MITY-LITE, INC., a Florida corporation, (hereinafter "Corporation").
