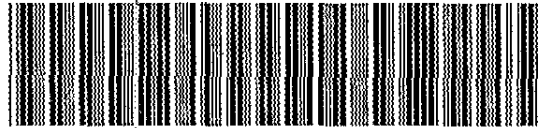

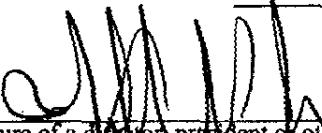

Article I of the Articles of Incorporation of the Corporation is hereby amended to Change the name of the Corporation to:

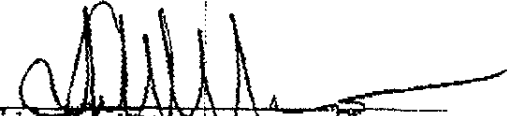
The Manno Corporation.
