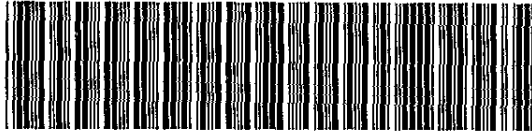

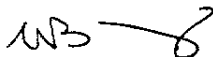

Under the following guidance from our lawyers, Aquent, Inc. needs to be re-qualified in Florida.

“Florida added the following provision: ‘Owning a limited partnership interest in a limited partnership that is doing business within this state [does not generally constitute doing business in Florida] unless such limited partner manages or controls the partnership or exercises the powers and duties of a general partner.’ Because Aquent LLC does transact business in this state, Aquent, Inc., an Authorized Class A Member, would need to qualify.”

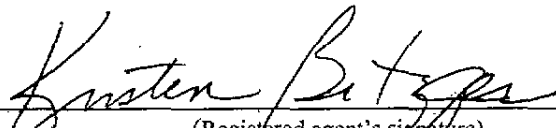

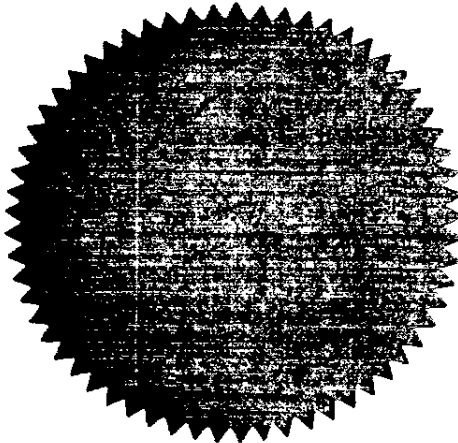
