





Please accept for filing, on behalf of the Republican Revish Coalition ("RJC") (a District of Columbia nonprofit corporation) the enclosed Application by Foreign Not for Profit Corporation for Authorization to Conduct its Affairs in Florida (in duplicate original) Also enclosed in conjunction with the Application are the following: (i) a certificate of good standing for RJC from the District of Columbia; (ii) the transmittal letter; and (iii) a check for \$70.00, payable to the "Department of State," which represents the filing fee.

RJC first began conducting its affairs in Florida in September of 2001 for the limited purpose of facilitating member meetings and communications. At that time, RJC was not certain whether it would remain in Florida on a permanent basis, and did not file an Application for Authorization to Conduct Business.

We have just recently decided to establish a permanent presence in Florida and are now taking the steps necessary to register in Florida, which includes filing the Application for Authorization to Conduct Business. As the Application asks for the date on which the corporation first conducted affairs in Florida, were not sure if RJC should list the date it began its limited activities in September of 2001 because those activities did not seem to rise to the level of "conducting affairs." Therefore, although we decided to list that initial starting date, our activities in the state since that time probably do not constitute "conducting affairs," and we ask that any potential civil penalty that may accrue to this filing be waived.
