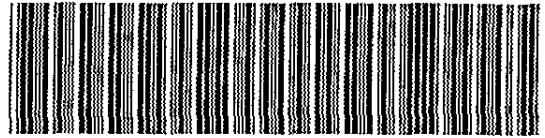

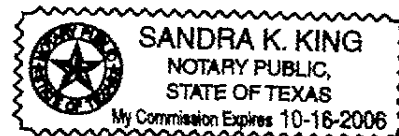

## PURPOSE STATEMENT

Cal Farley's Boys Ranch and Affiliates' purpose is to support the functions and purposes of Cal Farley's Boys Ranch, Cal Farley's Girlstown, U.S.A., Cal Farley's Family Program and the Cal Farley's Boys Ranch Foundation, all sec. 501 (c) (3) organizations, by providing centralized administrative, accounting, management, and fund-raising services.

The Cal Farley organization provides programs and services for at-risk boys and girls from throughout the United States at no charge to parents or relatives. Today, more than 360 children live at the three campus communities of Cal Farley's Boys Ranch, Cal Farley's Girlstown, U.S.A. and Cal Farley's Family Program. The educational needs of Cal Farley's Boys Ranch are met by the Kindergarten through 12th grade Boys Ranch Independent School District (BRISD).

During the fiscal year ending September 30, 2002, Cal Farley's Boys Ranch, Cal Farley's Girlstown, U.S.A., and Cal Farley's Family Program, served a total of 2,462 families and children, either in residence or through other outreach initiatives. The organization provided long term care for 522 boys and girls at the three Cal Farley residential communities. The Alumni Support Program served a total of 534 individuals during the fiscal year. Included in that number were a total of 114 alumni that were provided financial assistance to pursue college or vocational training programs after leaving the residential programs at Cal Farley's Boys Ranch and Cal Farley's Girlstown, U.S.A.

In a nurturing, structured environment, children from pre-school through high school live in group homes and enjoy a variety of academic, vocational, spiritual and extra-curricular activities to help them become responsible and resilient young people. They enjoy opportunities to develop social values and ethical principles while developing into responsible, independent and resilient adults.

Among the high school graduates at Boys Ranch, the average length of stay was three years and seven months; the average among graduates at Girlstown was approximately two and one half years. The average length of stay for children who left before high school graduation was one and one half years. In our ongoing effort to assist families with alternatives when basic residential care is not appropriate, our Information and Referral Specialists referred 2,064 families to alternative service providers.
