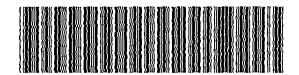

RMC FLORIDA GROUP, LIMITED (originally called TENWOOD LIMITED changed its name on 24th November 2003 to RMC FLORIDA GROUP LIMITED which was changed on 26th November 2003 to RMC FLORIDA GROUP, LIMITED each change having been made by special resolution) was incorporated under the Companies Act 1985 as a limited company on 19th November 2003.

According to the documents on the file of the company in the custody of the Registrar of Companies, the company has been in continuous and unbroken existence since the date of its incorporation.
