

This will respond to your letter of January 12, 2004, concerning the above-referenced entity. It is our understanding that this filing is now in order, with our filing with your office of a certificate of good standing from the entity's domiciliary state of Ohio.

Your letter poses one follow-up question as to whether the entity has already "transacted business" in Florida as that term is described in section 607.1501(1), Florida Statutes. As discussed below, the entity is in the business of entering into insurance contracts with qualified Floridians or with regard to qualified property situated in Florida. These contracts are developed in Ohio, issued from Ohio, and full-execution and the establishment of a contractual relationship occurs in Ohio. Performance under the contracts, on the part of the entity, occurs at the behest of personnel in Ohio.


Your letters refer to subsection 607.1501(1), Florida Statutes, which provides as follows: "A foreign corporation <u>may not</u> transact business in this state until it obtains a certificate of authority from the Department of State." (Emphasis added to highlight discretionary language, versus "shall not"). Subsection 607.1501(2) qualifies this subsection by indicating as follows:

"The following activities among others, do not constitute transacting business....

(c) Maintaining bank accounts.

(e) Selling through independent contractors.

(i) Transacting business in interstate commerce.

(Emphasis added to highlight broad scope of listed and unlisted exceptions). Subsection 607.1501(3), confirms the expansive breadth of exceptions by indicating that "[t]he list of activities in subsection (2) is not exclusive." These and other exceptions cover the various activity performed by this entity.

We also note that Florida's courts have reviewed similar situations. In the case of *Direct Mail Specialist, Inc. v. Terra Mar Group, Inc.*, for example, the foreign corporation accepted a service agreement out of state and the services rendered under that agreement transpired exclusively within the stream of interstate commerce. As such, the court ruled that these transactions were protected by the Commerce Clause of the United States Constitution. *Direct Mail Specialist, Inc. v. Terra Mar Group, Inc.*, 434 Do. 2d 1027, 1029 (Fla. 2nd DCA 1983). In 1931, the Florida Supreme Court instructed that the corporate status of a foreign corporation will be recognized in Florida by comity in all cases where recognition is not specifically prohibited by local laws. *Herbert H. Pape, Inc. v. Finch*, 102 Fla. 425,136 So. 496 (1931). The United States Court of Appeals for the Fifth Circuit ruled that Florida cannot require a foreign corporation to obtain a certificate of authority to do business when the corporation is engaged only in interstate business in Florida. And, the fact that a foreign corporation sends salesmen into Florida, if they are sent there only to promote interstate business, does not itself subject the corporation to regulations imposed by Florida. *Norman M. Morris Corp. v. Weinstein*, 466 F.2d 137, 142 (5th Cir.1972).

So, concerning Item 6 of the subject filing, the entity has "transacted business" but not within the meaning of section 607.1501(1), Florida Statutes. On behalf of this entity, we trust that the foregoing adequately responds to the Department's letter of January 12, 2004, and that the Department's records will bear no suggestion of non-compliance or penalty. If we can provide any further information, please do not hesitate to contact us directly.
