



We spoke several days ago regarding the attached letter. I would like to try to explain my present situation and ask if there is any relief that might be granted regarding the penalties and fines imposed due to our oversight in registering with the State Department as a non-Florida corporation doing business in Florida.

I took over control of our company about 5 years ago with the death of the founder and CEO, Curtis Baggett. Up until that time, we had a branch in South Florida who was registered with your department in Florida. We have a sales and use tax number with Florida and we do pay Florida corporate income tax.


If you could please review our situation and see if some relief could be granted for the penalties and fines levied, it would be greatly appreciated.
