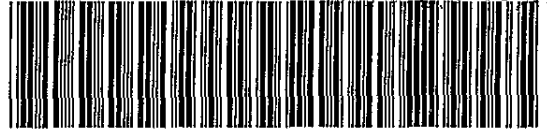


Please note that your letter referenced above was sent to the wrong address and was not delivered until months later. You addressed the letter to Mary Feeney rather than to our company name. The postal service returned it to you because there was no suite number and they did not recognize the employee name. I have attached copies to verify this. ✓

Regarding the penalty, we ask for it to be waived for the following reason. Our corporate office (registered in Delaware) registered our company for a foreign registration in Florida through the website: MyFlorida.com. To their knowledge, this was completed because they received **confirmation number 0208 1926 719** on August 19, 2002. Therefore no further action was taken. It was not until we had a sales tax issue that the City of Jacksonville notified us that we were not registered as a corporation. At that time, we took IMMEDIATE steps to resolve the problem. ✓

Things were further delayed because your department wrote to the wrong address back in July. Because we acted in good faith in registering our corporation, we respectfully ask that the penalty be waived. Of course we will pay the normal annual fees. ✓

We await notification from you on the status of our request. ✓



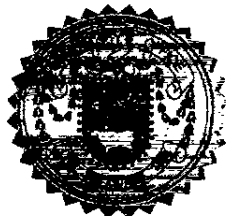
