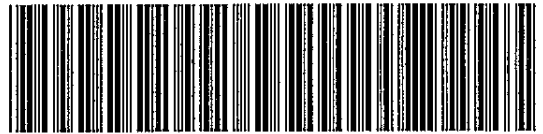

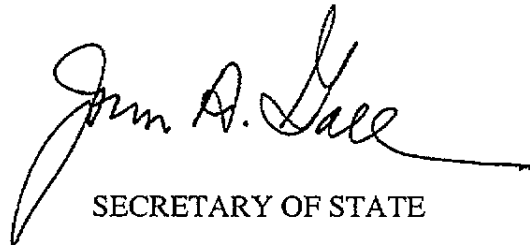

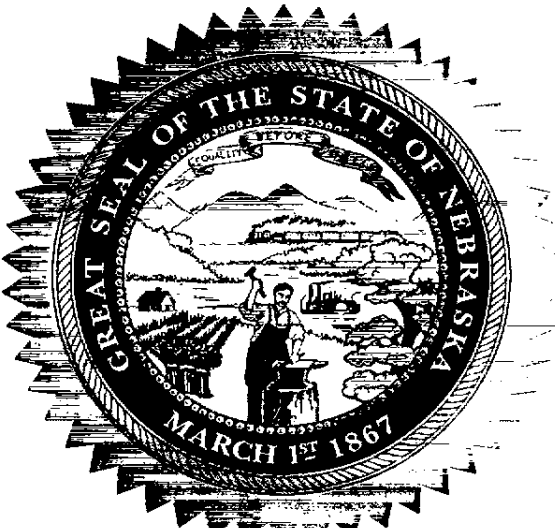

**ARTICLES OF INCORPORATION  
OF  
COMPANY #22**

The undersigned, acting as the incorporator of a corporation under the Nebraska Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation shall be Company #22

**ARTICLE II**

The aggregate number of shares which this corporation shall have authority to issue is Ten Thousand (10,000) shares, having a par value of One and no/100 Dollars (\$1.00) each, all of which shall be common stock.

**ARTICLE III**

The purpose for which this Corporation is organized is any lawful purpose permitted under the laws of the State of Nebraska as contemplated by the provisions of *Neb. Rev. Stat. § 21-2024*, as amended.

**ARTICLE IV**

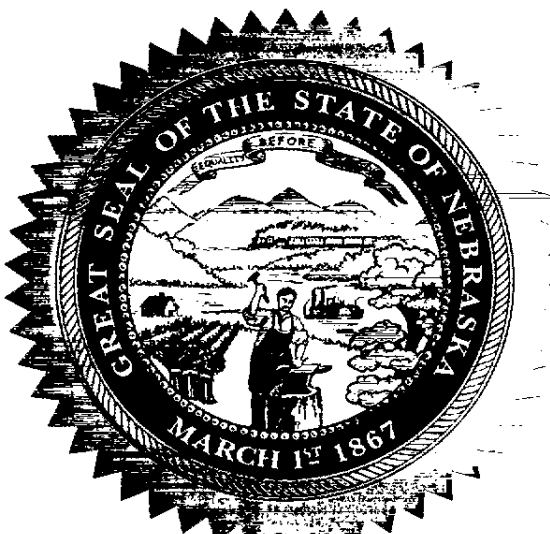

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
COMPANY #22**

Pursuant to the provisions of the Nebraska Business Corporation Act ("Act") the undersigned officer of Company #22, a Nebraska corporation (hereinafter the "Corporation"), hereby adopts the following Articles of Amendment to the Corporation's Articles of Incorporation:

**FIRST:** The name of the corporation is Company #22.

**SECOND:** The Articles of Incorporation are hereby amended by amending Article I as follows:

**ARTICLE I.**

The name of the corporation shall be Specialty Interior Services, Inc.

**THIRD:** Such amendment was adopted and approved by a two-thirds majority of the shareholders entitled to vote on the amendment in accordance with Section 21-20,118 of the Act and by unanimous written consent of the shareholders of the Corporation on the 9th day of June, 2004. At the time of such adoption, there were 8,000 shares of common stock outstanding, all of which were of the same class and entitled to vote on the proposed amendment. The number of shares voting for the amendment was 8,000 and the number of shares voting against the amendment was 0.
