Ordinarily, corporate registration would coincide with the TPA licensure date; however, because Creative Benefits is not required to be licensed as a TPA in Florida, Creative Benefits considers this corporate registration to be discretionary and considers its official date of commencement of corporate operations in Florida to be the date of this registration.


