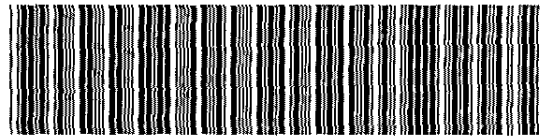





Copy of Statement of Purpose from By Laws

**ARTICLE IV.**

This corporation is organized exclusively for charitable, educational or religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code. Within those limitations, the specific purposes of the corporation are to benefit The Good News Broadcasting Association, Inc., a Nebraska nonprofit corporation, and such other nonprofit corporations which meet the requirements of Section 501(c)(3) and either 509(a)(1) or 509(a)(2) of the Internal Revenue Code, and which are in agreement with the statement of faith of The Good News Broadcasting Association, Inc. and which have philosophies of ministry consistent with the philosophies of ministry of The Good News Broadcasting Association, Inc. Such purposes include, but are not limited to, receiving, investing, reinvesting, managing and distributing, in whole or in part, restricted or unrestricted gifts, grants, bequests and devises for any and all of the foregoing purposes; to act in a fiduciary capacity respecting property or funds of which the Corporation is not the beneficial owner, provided the Corporation has some interest, whether present or contingent, in such property or funds; to appoint any bank or trust company authorized by law to exercise corporate trust powers to act as trustee or agent for any funds or property in the hands of the Corporation; to enter into gift annuity agreements with one or more individuals in exchange for donations to the Corporation, under terms prescribed from time to time by the Trustees; to increase public support for The Good News Broadcasting Association, Inc.; and to support the purposes of The Good News Broadcasting Association, Inc.


