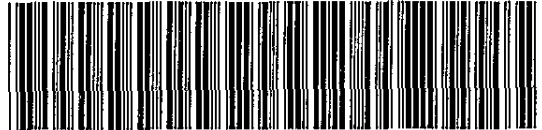



Dear Ms. Lunt:

I write to you as the presiding overseer of The Seafarer's Church of the Creator, which is an International Christian ministry and a religious order organized in 1975 for the Holy Purpose of spreading God's Word and appreciation for His created universe.

Earlier this year the church members decided to begin a church operation based in South Florida. Subsequently, we lawfully organized as a Not-For-Profit Corporation under the laws of the State of Nevada and pursuant to Florida State Statutes, have previously submitted our application for corporate registration as a not-for-profit corporation in Florida. The registration fee was included with the supporting documents.

For reasons not understood by me, you have returned the application package as deficient and included new forms intended for for-profit corporations. I know of no church or religious order that would organize or register as a for-profit corporation. Certainly, we, as a non-profit religious organization, will not register as a for-profit corporation.

You have also requested an additional document originating with the State of Nevada that was not provided to me upon formally and lawfully organizing in that state. How can your department request a supposedly superior document, testifying to the existence of our corporation, other than that which was supplied to me by the Nevada Secretary of State upon incorporation and acceptance? You must agree that your request is unreasonable and creates an artificial impediment to accomplishing your ministerial duties of simply registering our not-for-profit corporation.

Included with our Florida application for registration you found a certified copy of our Nevada Corporate Charter for our church dated May 07, 2004 (Exhibit #1). Also provided to you was a Nevada issued receipt (Exhibit #2), which clearly describes our corporation as a non-profit. (See highlighted area.

Further, a September 07, 2004 search of the Nevada Secretary of State's Corporation Database produced a two page set of documents (Exhibits #3 and #4), which were also included in our application package for your review and which show clearly that:

1. Status: Initial list of officers filed
2. Corporate Type: Non-Profit
3. Resident Agent information (See Highlighted Areas.)

All documents provided to me from the State of Nevada evidencing the lawful existence and positive status of our church corporation were included in our application package previously.

Being that Nevada's corporation records are fully "on-line", please examine the website yourself for additional verification of all items presented.

Re-Submittal

Attached to this letter please find our re-submittal of all previous documents, modified as exhibits, which along with the retained monetary instrument in the amount of \$87.50, should allow you to properly record our not-for-profit corporation in Florida.

Authority

For my authority in making this second application, I rely on the legal principal of COMITY, which exists between the States and my own personal status as an emancipated creditor (no longer a debtor) as evidenced by my U.C.C.-1 Florida filing (Attached as Exhibit #5). Please refer to your legal staff for significance of this status change.

Purpose

My purpose for writing this letter and making this second application is to simply make a plain statement of facts and effect a corporate registration.

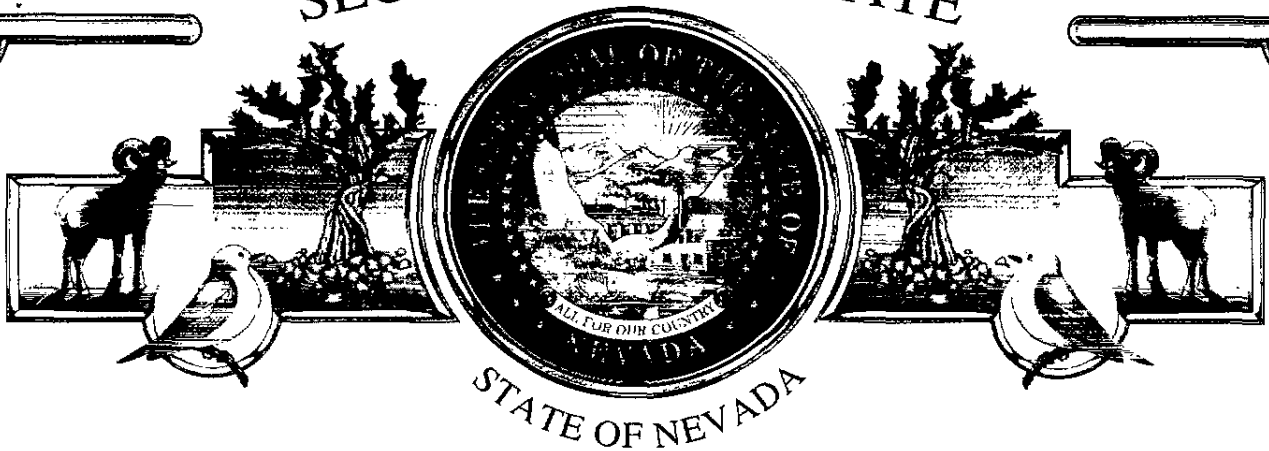
