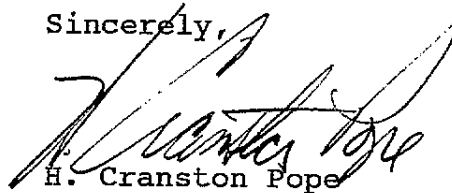

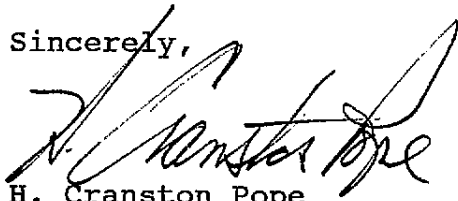

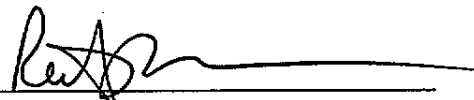

2. The foregoing amendment was adopted by the Stockholders and Directors of the corporation on the 29 day of January, 2002.

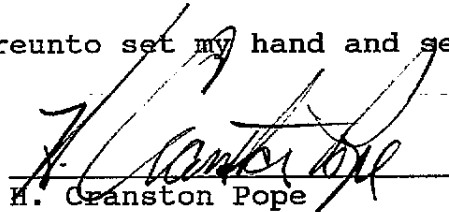
