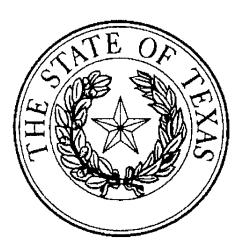

ARTICLES OF AMENDMENT TO

AMENDED AND RESTATED ARTICLES OF INCORPORATIONS Section OF SOFTECH INTERNATIONAL, INC.

SofTech International, Inc., a corporation formed under the Texas Business Corporation Act (the "Corporation"), hereby certifies:

FIRST: That the name of the Corporation is SofTech International, Inc. and the Corporation was originally incorporated on March 14, 1997 pursuant to the Texas Business Corporation Act, as amended (the "TBCA"). The Corporation amended and restated its Articles of Incorporation pursuant to Amended and Restated Articles of Incorporation of the Corporation as filed with the Secretary of State of the State of Texas on December 28, 2006.

SECOND: That the Board of Directors of the Corporation adopted resolutions approving and declaring advisable the following amendment to the Corporation's Amended and Restated Articles of Incorporation:

ARTICLE I of the Amended and Restated Articles of Incorporation of the Corporation is hereby amended in its entirety to read as follows:

"ARTICLE I

The name of the corporation is 360training.com, Inc. (the "Corporation")."

THIRD: The amendment to the Amended and Restated Articles of Incorporation effected by these Articles of Amendment was adopted and approved in the manner required by the TBCA and by the constituent documents of the Corporation.

The Board of Directors of the Corporation adopted resolutions to approve the amendment effected by these Articles of Amendment by an action by unanimous written consent dated February 26, 2007.

At the time of such adoption and approval, the Corporation was authorized to issue an aggregate of 15,000,000 shares of common stock, par value \$0.001 per share, of which 10,000,000 shares were issued and outstanding. The holders of the requisite number of shares of the Corporation to duly adopt and approve the amendment effected by these Articles of Amendment have voted in favor of such amendment by an action by written consent in lieu of a meeting of the shareholders pursuant to Article 9.10A of the TBCA and Article Twelve of the Corporation's Amended and Restated Articles of Incorporation, and any written notice required by said Article 9.10A has been given or waived by such shareholders. The holders of all of the Corporation's issued and outstanding common stock executed the action by written consent of shareholders in favor of such adoption and approval.

FOURTH: This document shall become effective upon its filing by the Secretary of State of the State of Texas.
