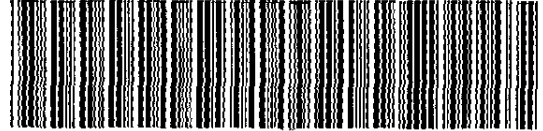

Pursuant to section 607.1502(4), 617.1502(4) or 608.502(4), Florida Statutes, this office collects a civil penalty of \$1000 for each year this entity transacted business or conducted its affairs in Florida prior to qualification and the appropriate annual report/uniform business report fees that would have been due this office had the entity qualified the year it began operations in this state. The amount due this office to cover both annual report/uniform business report and penalty fees is \$5,750.00.

Dear Ms. Lunt,

We are in receipt of your letter dated October 28, 2005 regarding the application for qualification of Optoma Technology, Inc. (the "Company").

Your letter indicated that the Department of State (the "Department") collects a civil penalty of \$1,000 for each year the Company transacted business in Florida prior to qualification. The Department assessed a penalty of \$5,750 on the Company.

After carefully reviewing Section 607.1501, Florida Statutes (the "Statute"), the Company believes it has not transacted business in Florida within the meaning of the Statute. The only business activities the Company conducted in Florida for the past years were soliciting orders which required approval and acceptance by the Company in its headquarters in California. Therefore, the Company believes it falls within Subsection 607.1501(2)(f) under which such activities do not constitute transacting business in Florida.

When the Company filed the Application by Foreign Corporation for Authorization to Transact Business in Florida, the Company listed January 1, 2000 in item #6 as the date the Company "first transacted business in Florida." The Company did not fully comprehend the meaning of "transacting business in Florida" under the Statute. Therefore the date was inaccurate and the Company hereby submits a new application form for the authorization.

Enclosed please find the new application form with the registered agent's signature. The certificate of good standing from California Secretary of State is also included for your review. If you have any questions or require additional documents, please do not hesitate to contact me. Thank you for your assistance in this matter.

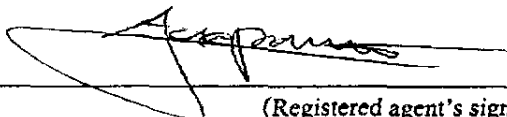
