

AMENDED AND RESTATED

ARTICLES OF INCORPORATION

OF

CARDIF PROPERTY AND CASUALTY INSURANCE COMPANY)

ARTICLE ONE

The name of the Corporation is Cardif Property and Casualty Insurance Company (the "Corporation").

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The locality of the statutory home office of the Corporation is in Kerrville, Texas. The locality of the principal administrative office of the Corporation is the City of Miami, State of Florida.

ARTICLE FOUR

The purposes for which the Corporation is organized are:

- (a) To engage in the business of insurance of the kinds set forth in Article Five hereof;
- (b) To issue policies for all kinds of insurance set forth in Article Five hereof, except as prohibited by law;
- (c) To engage in any other business permitted by law for a corporation engaged in the business of insurance of the kinds set forth in Article Five hereof; and
- (d) To have and exercise all rights and powers that are implied or from time to time granted by law to a corporation engaged in the business of insurance of the kinds set forth in Article Five hereof.

ARTICLE FIVE

The Corporation proposes to engage in the following kinds of insurance business:

(a) Fire insurance and its allied lines, including windstorm, and inland and ocean marine insurance and allied lines;

- (b) Guaranty, fidelity and surety insurance;
- (c) All kinds of general casualty insurance, including, but not limited to, insurance against:
 - (1) Bodily injury, disablement or death resulting from accident and disablement resulting from disease;
 - (2) Loss or damage resulting from accident to or injury sustained by an employee or other person for which accident or injury the insured is liable, including liability under workers' compensation laws;
 - (3) Loss or damage by burglary, theft or housebreaking;
 - (4). Glass breakage
 - (5) Loss from injury to person or property which results accidentally from steam boilers, elevators, electrical devices, engines and all machinery and appliances used in connection therewith or operated thereby, including insurance for boilers, elevators, electrical devices, engines, machinery and appliances;
 - (6) Loss or damage by water to any goods or premises arising from the breakage or leakage of sprinklers and water pipes;
 - (7) Loss resulting from accidental damage to automobiles or caused accidentally by automobiles;
 - (8) Loss or damage resulting from accident to or injury suffered by any person, for which loss and damage the insured is liable;
 - (9) Loss or damage to those matters which are made the subject of marine insurance as defined or may be defined by the laws of the State of Texas; and
 - (10) Any other casualty or insurance risk which may be lawfully made the subject of insurance by virtue of the laws of the State of Texas except life insurance.

ARTICLE SIX

The aggregate number of shares which the Corporation shall have authority to issue is Fifty Thousand (50,000) of the par value of Sixty Dollar (\$60.00) each, for a total authorized capital of Three Million Dollars (\$3,000,000). At least fifty percent (50%) of the authorized shares of capital stock will be issued and outstanding at all times. Each share of capital stock of the Corporation shall be equal in all respects as to other shares. All shares of capital stock shall be fully paid.

The amount of the Corporation's capital stock is Three Million Dollars (\$3,000,000), and the amount of the Corporation's surplus is Five Hundred Thousand Dollars (\$500,000). Five Hundred Thousand Dollars (\$500,000) of the Corporation's capital and Five Hundred Thousands (\$500,000) of the Corporations's surplus are in cash at the time of incorporation.

The Corporation shall maintain capital in an amount of at least One Million Dollars (\$1,000,000) and surplus in an amount of at least One Million Dollars (\$1,000,000) at all times.

ARTICLE SEVEN

The address of its registered office is 1614 Sidney Baker Street, Kerrville, Texas 78028-2640, and the name of its registered agent at such address is Legal Registered Agent Services, Inc.

ARTICLE EIGHT

The authorized number of directors of the Corporation shall be ten (10), but this number may be increased or decreased from time to time as set forth in the Amended and Restated Bylaws, but the authorized number shall never be less than seven (7). Directors shall be elected at the annual meeting of the shareholders which will be held prior to May 1 of each year. The Directors shall be elected by the shareholders qualified to vote and shall hold office until a successor is elected and qualified, or until his earlier death, resignation or removal from office as provided in the Amended and Restated Bylaws of the Corporation.

The Board of Directors of the Corporation must keep a full and complete record of all Board transactions. The Board of Directors shall elect a director to serve as the president and shall elect all other officers as provided in the Bylaws.
