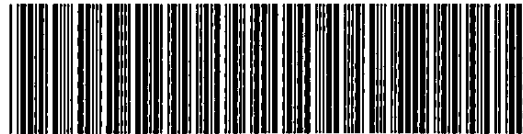

On September 26, 2006, *Applied Systems, Inc.*, an Illinois corporation with the Federal Tax Identification Number 36-3482937, merged into *Yellowstone Holding Company*, a Delaware corporation, and out of existence. On the same day, *Yellowstone Holding Company* merged into *BC Yosemite Holdings, Inc.*, another Delaware corporation, with *BC Yosemite Holdings, Inc.* as the surviving entity.
