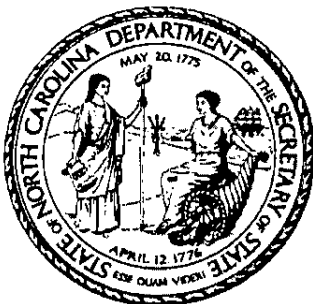
CERTIFICATE OF REINSTATEMENT FROM SUSPENSION
