Enclosed is a check for the civil penalty you assessed (\$4,600.00) for failure to qualify our operations in the State for the tax years ending 12/31/2003-12/31/2005. We have included this check as a good faith effort to complete all registrations within the state.

Prior to receipt of your letter, we had voluntarily presented our company, Chaparral Boats, Inc. to Florida because we realized that we may have unknowingly incurred tax liability in the state. We formally filed a Voluntary Disclosure Agreement ("VDA") with Kathleen Marsh of the Department of Revenue. It was our understanding under the agreement that the Department of Revenue, and the state of Florida, would waive all penalties associated with prior non-compliance pursuant to Fla. Stat.
